A STAKES FOR GOLDEN STATE SERIES ELIGIBLE CALIFORNIA BRED OR CALIFORNIA SIRED FILLIES AND MARES, THREE YEARS OLD AND UPWARD Bu subscription of \$50 each, which shall accompany the nomination, or by supplementary nomination of \$2,000 (all fees included) by time of entry for Golden State Series eligible horses. (Non-Golden States series eligible horses, \$25,000 to supplement by time of entry - such horses shall not have to pay the starting fee and will be automatically eligible to all future Golden State Series Stakes, subject to regular nomination and starter fees) An additional \$750 to start, with \$75,000 Guaranteed with \$42,750 to the winner, \$14,250 to second, \$9,000 to third, \$4;500 to fourth \$3,000 to fifth and \$1,500 to sixth. Weight: three-year-olds, 122 lbs.; Older, 125 lbs. Non-Winners of a Sweepstakes in 2024 allowed 2 lbs.; Non-winners of an Allowance Race allowed 4 lbs. Starters to be named through the entry box by the closing time of entries. High weights preferred. Preference for horses with equal weights will be determined by 2024 non-claiming earnings.
